### SECTION 4: FIRST AID MEASURES

#### 4.1 Description of first aid measures:

Request medical assistance immediately, showing the SDS of this product.

##### By inhalation:

This product does not contain substances classified as hazardous for inhalation, however, in case of symptoms of intoxication remove the person affected from the exposure area and provide with fresh air. Seek medical attention if the symptoms get worse or persist.

##### By skin contact:

Remove contaminated clothing and footwear, rinse skin or shower the person affected if appropriate with plenty of cold water and neutral soap. In serious cases see a doctor. In all cases, after cleaning, a doctor should be consulted as quickly as possible with the SDS of the product.

##### By ingestion/aspiration:

Request immediate medical assistance, showing the SDS of this product. Do not induce vomiting, because its expulsion from the stomach can be hazardous to the mucus of the main digestive tract, and also risk damage to the respiratory system through inhalation. **SECTION 5: FIREFIGHTING MEASURES****5.1 Extinguishing media:****Suitable extinguishing media:**
